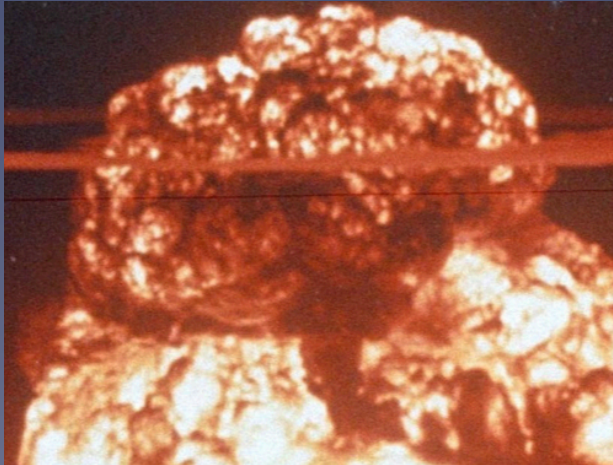

## DAVE KRIEGER, MANAGING MEMBER, DK CONSULTANTS OF FLORIDA

Dave Krieger, the host of this event, is the author of numerous books, the most infamous being **Clouded Titles**. Dave has taught dozens of workshops and seminars all across America on foreclosure defense and probate and has acted as a trial consultant, issued fact-based witness statements and declarations and has worked in a paralegal and consulting capacity for attorneys all across the U.S. in foreclosure cases, analyzing chains of title and pleadings and authoring responses and initial complaints. Dave's team has also conducted land record audits and forensic examinations of publicly-recorded documents in Osceola County, Florida and Williamson County, Texas, issuing voluminous reports that have been relied on as research evidence by foreclosure defense attorneys everywhere.

Dave is a veteran news director and radio broadcast the current talk host of the nationally-syndicated radio show **The Krieger Files**, which is a dot-com site that hosts the show Monday through Friday, which also broadcasts via the Global Star Radio Network to radio stations across the country by satellite, focusing on legal, financial and consumer issues. Dave serves as President of Florida Broadcast Media Group Inc. as well as Executive Director of the non-profit Natural State Community Radio Corp.

## BILL PAATALO, LICENSED PRIVATE INVESTIGATOR, BP INVESTIGATIONS

William Paatalo is a nationally recognized expert in mortgage fraud investigation, chain of title analysis, and securitization forensics. A licensed private investigator (OR PSID #49411), former police officer, and former president of a multi-state mortgage brokerage, he brings a rare, multidimensional perspective to one of the most complex financial deceptions in modern history.

Since 2009, Mr. Paatalo has investigated over 1,500 securitized mortgage transactions, provided expert witness testimony in dozens of state and federal courts nationwide, and issued over 450 sworn declarations in support of homeowners battling unlawful foreclosures. He is the author of the widely circulated investigative abstract, "How Your Mortgage Became a Wall Street Security Without Your Knowledge," which has become a foundational document in exposing the fraud of mortgage securitization, derecognition, and off-balance-sheet accounting. His abstract traces the entire scheme—from the misrepresentation of loan origination, through phantom trust structures, to the manufacturing of standing through fabricated assignments.

What makes Mr. Paatalo's work uniquely compelling is that it didn't begin in theory—it began with lived experience. In 2007, he became a direct victim of the very predatory machinery he now investigates. After losing multiple properties to manufactured defaults, he began representing himself pro se, researching the mechanics of securitization, and ultimately uncovering the systemic architecture of fraud behind what appeared to be routine foreclosures.

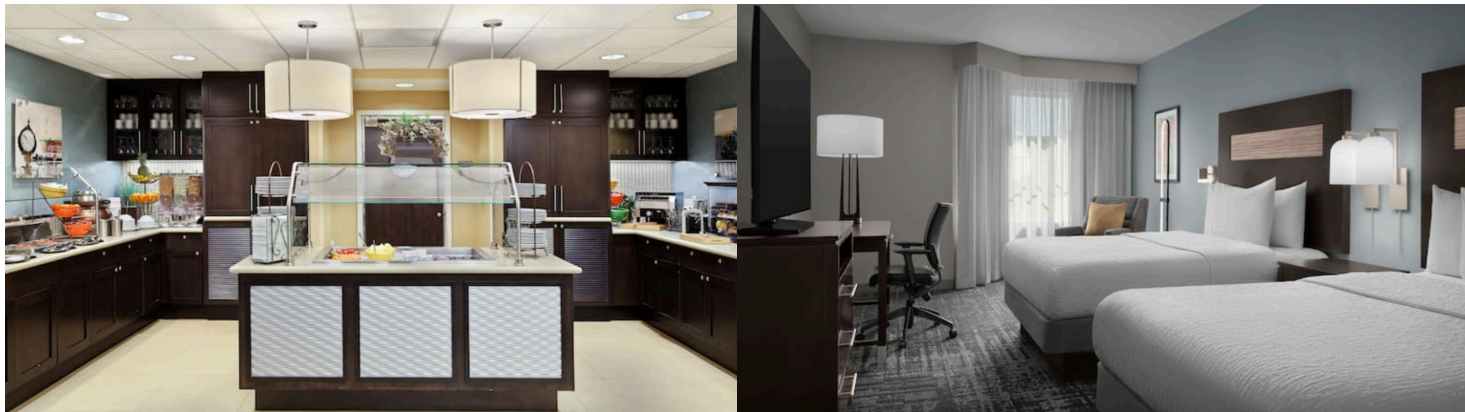
Over the past 15+ years, he has examined tens of thousands of pages of case files, SEC filings, trust agreements, subpoena responses, servicing testimony, and public land records. His work reveals a shell game of concealed creditors, derecognized loans, and a foreclosure system sustained by judicial presumption and document fabrication.



Mr. Paatalo's mission today is clear: to empower others to take back control using a commercial and administrative process rooted in law, accounting, and hard evidence. His seminar will guide attendees through that process, showing how to shift the burden of proof, force disclosures, and record defaults in the land records to preserve rights and expose fraud.
